Open to all Flower City Arts Center members. Membership must be current through April 25, 2025.

Artwork Drop-Off: February 24 - 28 / 9am - 6pm

Exhibition Dates: March 7 - April 24

Opening Reception: First Friday / March 7 / 6 - 9pm

ENTRY SPECIFICATIONS:

- Drop off your work and fill-out the entry form during the above time frame.
- Each member artist can submit one work of art. All 2-D artwork **must be “ready to hang”** including wire and/or all necessary hardware.

- Any exhibited work that is available for sale in the exhibition must be sold through Flower City Arts Center for the duration of the exhibit. Installations are not accepted.
- Work will not be accepted if delivered by freight. (UPS, FedEx, or USPS only).
- Flower City Arts Center reserves the right to reject submissions based on space restrictions.

SUBMISSION PROCESS:

Fill out **Entry Form** and submit with work in any Flower City Arts Center program area in person during open office hours: *Mon - Fri. 9am - 6pm; Sat. 12 - 5pm.*

SHIPPING (Drop-Off Preferred):

- Shipped artwork must be received February 24 - 28. Include form with shipped artwork.
- Participants are responsible for all shipping and insurance expenses to and from the gallery. Work must be sent in a substantial, reusable packing crate or box.
- Any artwork without pre-paid return that is not picked up after 14 days of the close of the show becomes the property of Flower City Arts Center.

Every reasonable precaution will be taken during the receiving, installation, exhibition, and return of the work. Flower City Arts Center, its employees and volunteers will assume no responsibility for loss or damage incurred. It is recommended that artists carry their own insurance during shipping and exhibition. Any artwork without pre-paid return that is not picked up after 14 days of the close of the show becomes the property of Flower City Arts Center. Flower City Arts Center reserves the right to use images of accepted artwork for promotional and educational purposes.
